Te Pūrongo a te Tumuaki o te Poari me te Kaiwhakahaere Matua Board Chair & Chief Executive's Report

Tenā koutou katoa,

As we reflect on the past year, we do so with deep gratitude for the resilience, innovation, and aroha shown by our communities across Tairāwhiti, Hawke's Bay, Tararua, Wairarapa, Manawatū, and Horowhenua. The 2024/25 year has been one of both challenge and transformation, and we are proud to share the progress we've made together.

Navigating Complex Challenges

Our communities continue to face the compounding impacts of climate change, economic hardship, and social inequities. The aftermath of Cyclone Gabrielle remains a stark reminder of the vulnerability of our infrastructure and ecosystems. Rising living costs, housing insecurity, and youth unemployment have placed immense pressure on whānau and community organisations alike.

Yet, amidst these challenges, we have witnessed extraordinary leadership, collaboration, and courage. Community groups have stepped up to meet urgent needs, while also laying the groundwork for long-term, transformational change.

Strategic Progress

Guided by our 2023–2030 Strategic Plan, we have focused our efforts on four pou: Tū Māori Mai, Kaitiakitanga (Environment), Mana Taurite (Equity), and Hononga (Partnerships). These pillars reflect our commitment to equity, sustainability, and community-led development.

This year, we:

- · Supported initiatives that uplift Māori aspirations, including marae development, rangatahi leadership, and Te Reo revitalisation.
- Invested in climate resilience and biodiversity restoration through community-led environmental projects.
- Prioritised equity by funding programmes that address systemic barriers for underserved communities.
- · Strengthened partnerships with iwi, hapū, local government, and other funders to amplify collective impact.

Community Investment and Impact

In 2024/25, ECCT distributed over \$6,061,441 in grants, supporting 361 projects across our rohe. These investments reflect our belief in the power of local solutions and the importance of long-term, trust-based relationships.

We continue to evolve our funding approach, embedding principles of equity, partnership, and social impact. This includes \$737,996 of multi-year funding paid in 2025 and a growing focus on impact.

Highlights include:

- Establishing a three-year partnership with Hawke's Bay Biodiversity Trust in conjunction with Hawke's Bay Regional Council to increase the funding available through the Environmental Enhancement fund.
- Collaborative funding in Tairāwhiti to support solar panel installations across 22 marae in rural and isolated communities.
- Supporting Kainga Whakatipu Healthy Homes initiative in Manawatū with multi-year funding to improve the health outcomes for children and whanau with funding initiatives for warmer, dryer and safer homes.

Financial Stewardship

Our investment portfolio delivered a return of 5.08%, enabling us to maintain a stable grants budget while growing our reserves for future generations. We remain committed to responsible investing, including exploring opportunities for impact investment aligned with our strategic goals.

Governance and Leadership

We welcomed new trustees Rodney Wong (Manawatū) and Ashleigh Gilmour (Hawke's Bay), and farewelled two trustees, Gail Munro (Manawatū) and Whiti Timutimu (Tairāwhiti) with heartfelt thanks to both for their valuable contributions. Our board continues to reflect the diversity and strength of our region, and we are grateful for their wisdom and guidance.

Looking Ahead

As we move into 2025/26, our focus will be on:

- Deepening our support for Māori-led solutions and intergenerational wellbeing.
- · Scaling climate action and environmental stewardship.
- Strengthening the resilience of community organisations.
- Enhancing our data and insights to inform equitable decision-making.

We are also committed to living our values—Ngākau Pono (Integrity), Kaha (Courage), Ngākau Whakaute (Respect)—in all that we do.

Impact & Partnership Fund Highlights

The following grants are a small sample of the Impact and Partnership Fund recipients in 2024/25, each demonstrating clear alignment with ECCT's vision of creating "courageous transformational change to enable vibrant, more sustainable and equitable communities." These initiatives span diverse regions and focus areas, showcasing the power of strategic investment in community-led solutions that deliver lasting impact.

Hawke's Bay Biodiversity Trust

Grant Amount: \$330,000 over three years **Region Supported:** Hawke's Bay

Hawke's Bay Biodiversity Trust is leading a coordinated, community-driven effort to restore and enhance indigenous biodiversity across the region. Formally established in 2018, the organisation serves as a regional hub—connecting people, projects, and partners to deliver on the goals of the Hawke's Bay Biodiversity Trust Strategy 2015–2050. In partnership with the Hawke's Bay Regional Council and with ECCT's support, Hawke's Bay Biodiversity Trust is removing barriers for individuals and groups wanting to act, by providing administrative, financial, and project management support.

The organisation fosters a "network of networks," enabling collaboration between community groups, councils, and government agencies. A portion of the grant will go towards the annual contestable grant fund to accelerate grassroots biodiversity initiatives. Through this work, Hawke's Bay Biodiversity Trust is not only restoring ecosystems but also growing public awareness and engagement with biodiversity and sustainability. ECCT's investment is helping to build a thriving, resilient natural environment—one that is healthy, functioning, and collectively cared for by the people of Hawke's Bay.

Horowhenua District Health Transportation Trust

Grant Amount: \$58,500

Region Supported: Horowhenua

The Horowhenua District Health Transportation Trust has become a vital connector for residents in Levin, Foxton, Shannon, and Tokomaru, ensuring equitable access to essential healthcare. With ECCT's support, the Trust operates a free shuttle service to Palmerston North Hospital, removing transport as a barrier for those with limited mobility, financial hardship, or lack of support. Equipped with wheelchair hoists and disability access, the service is inclusive and essential, particularly for patients requiring regular dialysis or outpatient care.

Despite a small team of two staff and 50 volunteers, the Trust facilitated nearly 8,000 healthcare visits last year. This grassroots initiative is a powerful example of community-led care, improving health outcomes, reducing hospital no-shows, and easing pressure on families. ECCT's investment has enabled a quiet but deeply appreciated transformation in community wellbeing.

Nourished for Nil

Grant Amount: \$297,580 over three years **Region Supported:** Hawke's Bay

Nourished for Nil is leading transformational change in Hawke's Bay by tackling food waste and food insecurity through large-scale community action. As ECCT's first Community Partnership grant recipient, the organisation is using these funds to strengthen its food rescue and distribution efforts in Hastings and Napier. Volunteers collect surplus food from growers, manufacturers, supermarkets, and cafes, redistributing it free of charge to anyone in need—no eligibility criteria required.

In 2023 alone, Nourished for Nil rescued over 800 tonnes of food and distributed more than 82,000 food parcels, making a tangible difference in household wellbeing and environmental sustainability. The grant has enabled the organisation to plan long-term strategies with confidence, expand its reach, and deepen its impact.

Nurturers for Change

Grant Amount: \$62,000 **Region Supported:** Wairarapa

Nurturers for Change is delivering life-affirming transformation through kaupapa Māori-based rehabilitation and prevention programmes in the Wairarapa. With ECCT's support, the organisation is reconnecting individuals with te taiao (the natural world), mātauranga Māori (Māori knowledge), and their cultural identity—fostering a deep sense of belonging, purpose, and self-worth. Programmes such as Ngāhere-o-Tāne, Ngāhere-o-Wahine, and Ōhi Ora use healing approaches grounded in environmental stewardship, whānau support, and cultural reconnection.

Participants engage in conservation work, tree planting, and reflective learning that highlights the interconnectedness of all living things. The impact is tangible: whānau report restored relationships, improved emotional wellbeing, and renewed pathways into training and employment. Individuals once isolated are now building friendships, developing leadership skills, and contributing meaningfully to their communities. This holistic, strengths-based approach aligns powerfully with ECCT's pou of equity, environmental stewardship, and Māori advancement—demonstrating how kaupapa-driven innovation can create enduring, far-reaching change.

Palmerston North Hospital Foundation

Grant Amount: \$305,500 over three years **Region Supported:** Horowhenua and Tararua

Through a strategic partnership with Te Whatu Ora's Kāinga Whakatipu Healthy Homes Programme, the Palmerston North Hospital Foundation is addressing the root causes of poor health by improving housing conditions for vulnerable families. With ECCT's support, the programme now reaches an additional 50 households annually—particularly kaumātua, disabled individuals, and refugee families who often fall outside standard eligibility criteria.

The initiative provides essential items like curtains and heaters, offers practical advice on maintaining a healthy home, and advocates for necessary repairs. This whānau-centred approach is reducing preventable hospitalisations, helping children stay in school, and creating healthier, more resilient communities. Backed by strong evidence and driven by local collaboration, this grant is a clear example of systemic change in action.

Trust Tairāwhiti – Solar Marae Programme

Grant amount: \$340,000

(\$40K donated by Todd Foundation) **Region Supported:** Tairāwhiti

This major solar energy initiative is building long-term resilience for 21 marae across rural Tairāwhiti, enabling them to continue serving as vital community hubs during extreme weather events. With a total project cost of over \$2 million, the initiative was led by Trust Tairāwhiti and funded through a multi-partner collaboration, including a primary grant of \$856,979 from the Cyclone Gabrielle Appeal Trust (CGAT), alongside contributions from DIA, Te Puni Kōkiri, the Todd Foundation, and ECCT.

By installing sustainable solar energy systems, the project not only enhances emergency preparedness but also reduces long-term electricity costs. These savings will help fund ongoing maintenance, ensuring the systems remain viable for years to come. In addition to resilience benefits, the initiative is expected to deliver significant environmental outcomes and reduce energy hardship—making it a powerful example of community-led climate adaptation and infrastructure innovation.



Ngā Hua HaumitangaInvestment Performance


Eastern & Central Community Trust's ability to grant is underpinned by the performance of its Investment Portfolio. This relates to the long-term average return and not the return in any individual year, and the management of the investment risks over the short-term. Established in perpetuity, the Trust board looks to grow the value of our capital fund and maximise the funding available for granting. It also looks to maintain flexibility to respond to investment opportunities and special granting needs as they arise to benefit the community.

The Trust Board maintains responsibility for setting the objectives and policies and documents these in its Statement of Investment Policy and Objectives (SIPO). The key investment objective is to achieve a return above the long-term average inflation rate of 4.5% a year after investment expenses. In addition, in managing the investment risks to achieve each year an income return each year of 2.5% and over the medium term an average growth return above inflation to maintain the capital fund in real terms.

In the March 2025 year the Trust exceeded its income 2.5% target and achieved a 5.08% total return. The benchmark Index return was 7.4%.


Strategic Allocation of Financial Assets

Tauākī Whakatutukitanga Ratonga Statement of Service Performance

For the year ended 31 March 2025

The Board's principal responsibility is to invest the assets of the Trust in a range of diversified investments designed to sustainably deliver returns over the long term, whilst reserving for inflation and population growth. The Trust then distributes the returns in the most impactful way possible to achieve the Trust's purpose. In 2023/2024 the Trust implemented a new granting framework focusing on five key pou. The Granting framework was aligned with the new strategic focus with three new funds established. Community Support and Event fund up to \$10,000, Impact fund up to \$100,000 and the Rangatahi-Led fund up to \$25,000. A new Partnership fund replaced the Capital Assets & Facilities Fund, with the purpose of supporting charities over multiple years to enable transformational change.

Mahere Kōkiri Āhuarangi Climate Action Plan

ECCT remains firmly committed to our Climate Action Plan, with ongoing work focused on the three core goals designed to drive meaningful change.



Embedding climate responsibility into ECCT's daily operations and reducing and offsetting Green House Gases.

Emissions measurement - ECCT's achieved a healthy reduction in greenhouse gas emissions during the 2023-2024 reporting period, demonstrating its commitment to environmental sustainability.

Total emissions for the year were 20.9 tCO2e, down from 25.6 tCO2e in March 2023.

We measured the emissions resulting from our operational activities, purchased energy, and selected impacts from value chain activities, including business travel, freight, and waste sent to landfill.



Assessing ECCT's investment portfolio to ensure that its carbon exposure is reduced over time with the long term goal of being carbon neutral by 2050.

Examples of activity in this area include the following activity:

- C&ESG scoring by Equity Fund Manager Forsyth Barr enabled the measurement of our carbon emissions in our equity & bond investments. As of 31 March the Forsyth Barr C&ESG score was B for equity holdings(2024: B+), and B+ for NZ bonds (2024: Nil).
- Hunter Fund, Direct Capital, Pioneer, and Waterman continue to embed ESG principles across new investments.

Trustees have embedded climate change into the Statement of Investment Policies and Objectives to encourage and facilitate carbon reduction and sustainable investment and the timely transition towards global net zero emissions.







Supporting communities across ECCT's regions to understand and mitigate climate change impacts through our funding framework.

ECCT made significant strides supporting Kaitiakitanga as a key pou within the 2023-2030 Strategic Plan. This year marked the inaugural phase of funding aimed at fostering environmental stewardship across our rohe. ECCT established new relationships and key collaborations. The use of multi-year granting demonstrates ECCT's commitment to sustained and long-term impact for environmental initiatives.

ECCT continued its active participation in the Combined Community
Trusts Climate Action group. This collaboration marked a significant milestone with the establishment of the Kaupapa of National Significance fund, a pivotal initiative aimed at





The Kaupapa of National Significance fund embodies a clear and unified vision: to support projects that contribute to the long-term reduction of greenhouse gas emissions, enhance ecological resilience, and strengthen community climate preparedness. It also prioritises enabling a tika (equitable) transition and reflects a shared commitment to Te Tiriti o Waitangi, ensuring the integration of Māori aspirations in addressing climate challenges.

Notes to the Summary General Purpose Financial Report For the year ended 31 March 2025

1. Reporting Entity

The Eastern and Central Community Trust Inc. (Trust) is a Charitable Trust domiciled in New Zealand and incorporated in accordance with the provisions of the Community Trusts Act 1999.

The Trust is primarily involved in the management of the investment of assets, and the distribution of grants to the community within a designated North Island region of New Zealand.

Eastern and Central Community Trust Inc is a public benefit entity for the purpose of financial reporting. The financial statements of the Trust are for the year ended 31 March 2025 and were approved for issue by the Board of Trustees on 1 August 2025.

2. Basis of Preparation

(a) Statement of Compliance

The Summary General Purpose Financial Report has been prepared in accordance with Public Benefit Entity Standards as they relate to summary financial statements (PBE FRS 43) and have been extracted from the full financial statements.

For the year ended 31 March 2025 the Trust prepared its financial statements using the Public Benefit Entity Standards Reduced Disclosure Regime appropriate for Tier 2 Not-For-Profit Public Benefit Entities.

(b) Basis for measurement

The financial statements have been prepared on a historical cost basis modified as detailed in the specific accounting policies in the full financials statements except for investments and derivatives which are at fair value through surplus or deficit.

(c) Functional and presentation currency

These financial statements are presented in New Zealand dollars (NZD). All financial information has been rounded to the nearest dollar.

(d) Summary General Purpose Financial Report

The Summary General Purpose Financial Report is extracted from the full financial statements authorised for issue by the Trustees on 1 August 2025. Once issued the Trustees do not have the power to amend these statements. The full financial statements of the Trust have been audited by Baker Tilly Staples Rodway Audit Limited who have issued an unmodified audit opinion. Baker Tilly Staples Rodway Audit Limited have audited these summary financial statements and found them to be consistent with the full financial statements.

The Summary General Purpose Financial Report does not include all the disclosures provided in the full financial statements and cannot be expected to provide as complete an understanding as is provided by the full financial statements.

3. Related party transactions

From time to time, the Trustees may be involved at the governance level in grant recipient organisations. Total grants paid to these related donee organisations for the year was \$479,021 (2024: \$632,470). Trustees fees for the year were in total \$184,690 (2024: \$167,196). Senior Management fees for the year were in total \$329,845 (2024: \$319,369)

4. Contingencies & Commitments

The Trust has a commitment of \$17.4 million (2024: \$8.75 million) being the uncalled balance of the private equity funds with Pioneer Capital Partners Limited II \$32 thousand, Pioneer Capital Partners IV \$1.3 million, Waterman Capital III \$923 thousand, Waterman Capital IV \$1.5 million, Waterman Capital V \$5.9 million, Direct Capital V Limited Partnership \$438 thousand, Direct Capital VI \$1.1 million, Direct Capital VII \$6 million and Morrison & Co \$100 thousand.

The Trust has operating commitments with respect to a photocopier lease, software licence and capability funding totaling \$273,632 (2024: \$394,679).

Total grants payable at year end was \$1,362,150 (2024: \$1,400,606) which are subject to the applicants fulfilling certain conditions. The Trust has contingent liabilities of multi-year funding of \$1,419,926 that have not had the conditions met. (2024: \$530,000)

5. Subsequent events

There were no subsequent events of a material nature. (2024: After balance date \$51.8 million of share investments that were managed by Elevation Capital were transferred to Forsyth Barr to manage).

INDEPENDENT AUDITOR'S REPORT ON THE SUMMARY GENERAL PURPOSE FINANCIAL REPORT

To the Trustees of Eastern and Central Community Trust Inc.

Report on the audit of the Summary General Purpose Financial Report

Opinion

The summary general purpose financial report, which comprise the summary statement of financial position as at 31 March 2025, the summary statement of service performance, summary statement of comprehensive revenue and expense, summary statement of changes in equity and summary statement of cash flows for the year then ended, and related notes are derived from the audited general purpose financial report of Eastern and Central Community Trust Inc ('the trust') for the year ended 31 March 2025.

In our opinion, the accompanying summary general purpose financial report are consistent, in all material respects, with the audited general purpose financial report in accordance with PBE FRS 43 *Summary Financial Statements* issued by the New Zealand External Reporting Board (XRB).

Our report is made solely to the Trustees of the Trust. Our audit work has been undertaken so that we might state to the Trustees of the Trust those matters we are required to state to them in an auditor's report and for no other purpose.
